The United Nations Global Compact, created in 2000, currently has more than 13,000 member entities in more than 160 countries and 69 local networks. This social responsibility initiative operates in our country through the Spanish Network, which is currently made up of more than 1,945 entities, making it the Local Network with the largest number of members and, therefore, the most important in the world.

Of these 1,945 organisations, 22% are large companies, 62% are SMEs (small and medium sized enterprises) and 16% are other types of third sector entities, trade unions, business associations and educational institutions. The objective of the Spanish Network of the United Nations Global Compact is to promote the implementation of the Ten Principles of the Global Compact among the signatory entities for business sustainability and to contribute from the private sector to the achievement of the Sustainable Development Goals (SDGs).
